

## Steps of the Pay Without Registration

Firstly visit to <https://rajkosh.up.nic.in/> site.

1. Click on the "Pay Without Registration" option on the left corner of the home page.
2. Select Department SSK(Samajik Suraksha tatha kalyan vibhaag).
3. Select "one time deposit" in the Deposit Period field.
4. Select "Lucknow" in the Division Field.
5. Select "Jawahar Bhawan Lucknow" in the treasury field.
6. In the Remark field, enter "Registration" if you want Registration or "Renewal" if you want "Renewal".
7. Enter all the details on the right side.
8. Head: 023560800890000  
Description: Anya vividh praaptiyaan  
Serial No.: 13  
In this field enter the amount of 500 if Registration or 300 if Renewal is there.
9. Enter the Captcha.

- This is a 24X7 facility and citizen can make the payment any time of the day.
- On-Line Filling of single challan form facilitates minimum fields of the challan to be filled.
- Instant online receipts for payment made and instant online banks transaction number becomes available.
- One can pay personal taxes as well as behalf of the firm, company and others.

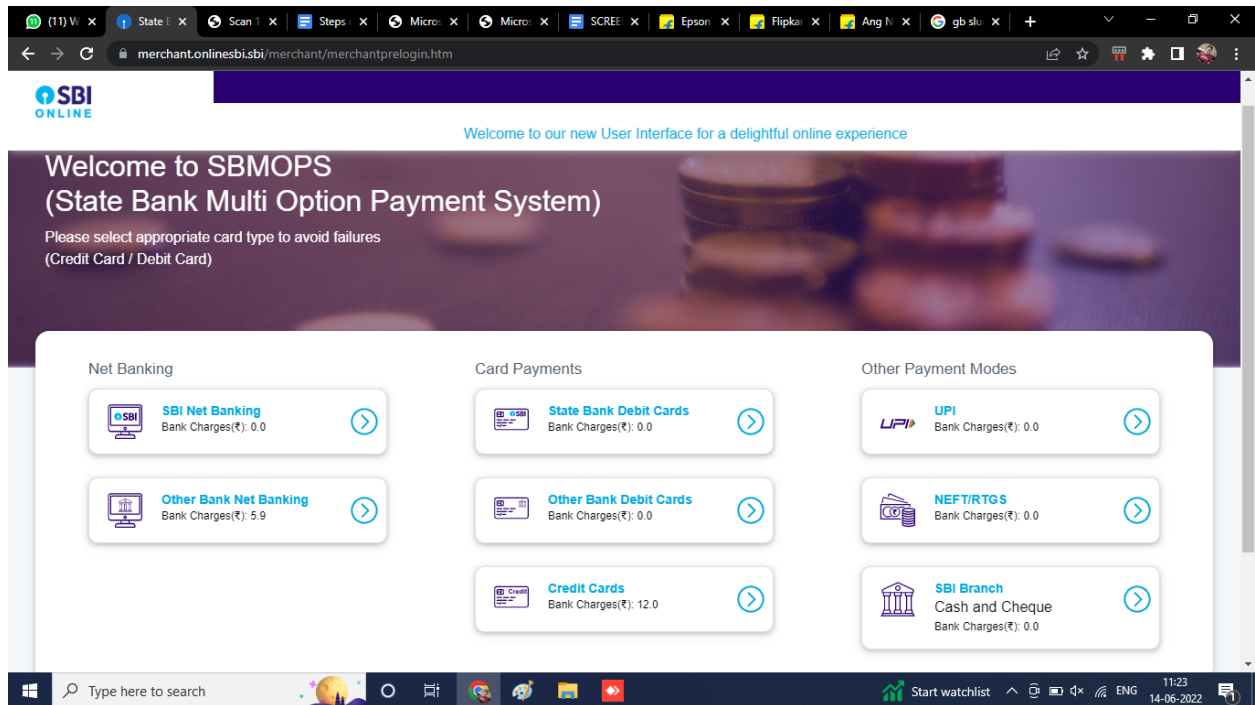

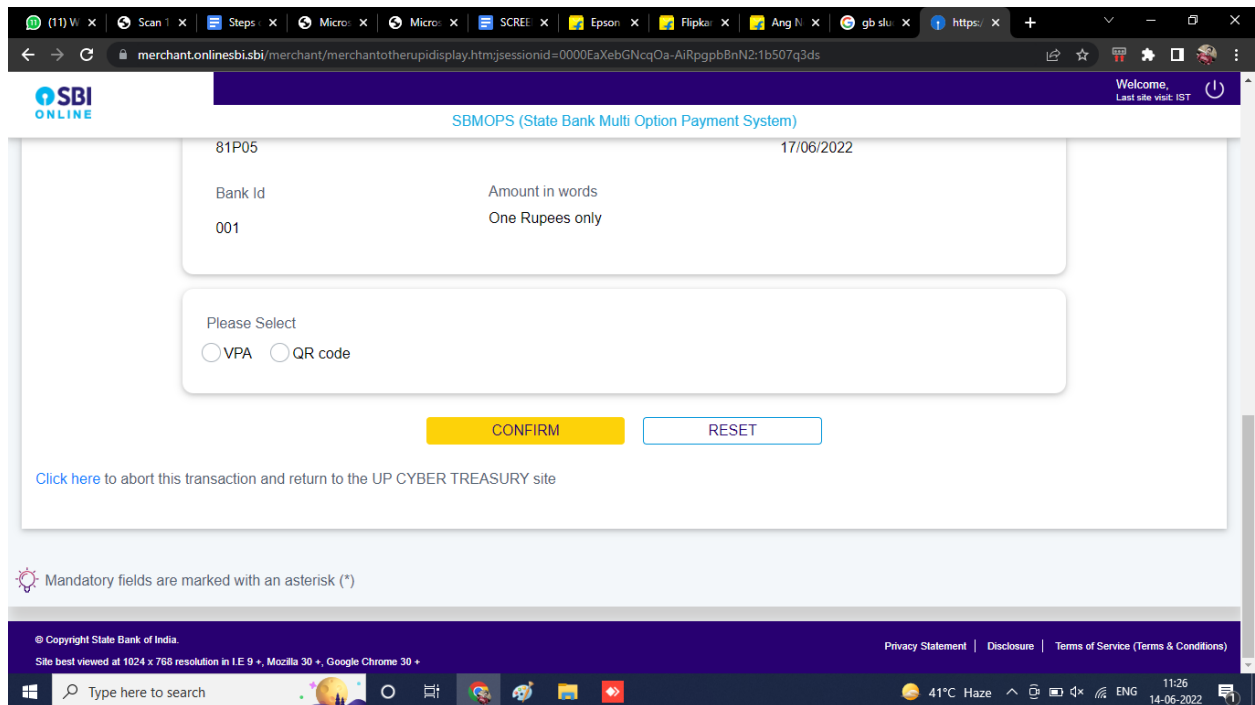
